Dear State Dislocated Workers Unit, Waukesha County Executive, and Mayor of Oconomowoc:

Please be advised that I represent Lake Country Foods, Inc.

Pursuant to appropriate federal and state WARN laws, notice is hereby given of Lake Country Foods, Inc.'s intent to completely and permanently close all operations located at 132 South Concord Road, Oconomowoc, Wisconsin. All operations will cease on March 15, 2018. This closing will affect approximately 91 employees. The first separation of employment will commence on March 16, 2018, for all employees, except those needed for plant maintenance, with the final separations of employment taking place prior to March 30, 2018. (A small number of employees will be retained for building and machinery maintenance). The job titles of the affected positions, the names of those employees currently holding those positions, and the names of the affected workers are attached to this notice. No bumping rights exist. All benefits and wages due will be paid consistent with federal and state law and the labor contract, where applicable.

The name of the union representing certain affected employees who are represented by the Teamsters union is Teamsters Local 695, located at 1314 N. Stoughton Rd., Madison, WI 53714. The names of the local Teamsters representatives are Vangie Moreno and Wayne Schultz.
