This letter is to inform you, pursuant to any obligation that may be required under applicable federal and/or state law, that ACCO Brands USA, LLC (the "Company") will permanently close its entire Pleasant Prairie Distribution Center located at 10303 80th Avenue, Pleasant Prairie, WI 53158 (the "Facility").

Based on the best information available to the Company at this time, we estimate the closing of the Facility will occur on May 31, 2018. At this time, the Company anticipates that employment separation will begin on March 23, 2018. We presently expect twenty-six (26) employees to be separated from employment effective between March 23, 2018 and May 11, 2018.

The Facility closing and employment separations will be permanent. Because the Company does not recognize bumping rights for its employees, terminated employees are not permitted to displace remaining employees based on seniority or any other factor. The employees are not represented by a union.

Affected employees will be paid all wages and other benefits to which they are entitled (if any) through the remainder of their employment with the Company, up until their date of termination. On or before the effective date of each employee's termination, the Company will provide information concerning benefits available under separate cover to eligible affected employees.

Attached hereto as "Schedule A" is a list of all affected positions and the number of affected employees in each job classification at the Facility. No applicable positions are represented by any collective bargaining representative. All affected employees are being notified of their employment terminations at least (60) days before their terminations are scheduled to occur.
