RE: WARN Notice - Business Closing

Dear Government Officials:

Safco Products Co. will be permanently closing its entire facilities located at:

- 619 and 705 N Commerce Street, Sheboygan, Wisconsin 53081;
- 1213A 1310 Pennsylvania Avenue, Sheboygan, Wisconsin 53081; and
- 4350 Tower Drive, Sheboygan, Wisconsin 53081.

This action is expected to result in the permanent elimination of the employment of over 127 employees – approximately 48 salary and 79 hourly positions. The company expects to begin eliminating positions and to implement employment separations of office employees in two phases: 1) on September 4, 2018 or the 14 day period that begins on that date, and 2) on November 2, 2018 or the 14 day period that begins on that date. The company also expects to begin eliminating positions and to implement employment separations of production union-represented employees in two phases: 1) on October 5, 2018 or the 14 day period that begins on that date, and 2) on November 2, 2018 or the 14 day period that begins on that date.

The hourly production employees are represented by the IUE-CWA, Industrial Division of the Communications Workers of America Union. The representatives of this union are:

- Randy Tayloe, President of Local 800, located at 1104 Wisconsin Avenue, Sheboygan, Wisconsin 53081; and,
- James D. Clark, President, IUE-CWA, located at 2701 Dryden Road, Dayton, Ohio 45439.

Attached is a list of job titles, number affected within each job title, and the expected layoff date. Bumping arrangements are not available for non-union represented affected employees, and any such arrangements applicable to union-represented employees would be governed by the applicable collective bargaining agreements. Please note that due to interplant bumping rights, resignations, and/or early retirement elections, it is impossible to predict with certainty which represented employees will ultimately be affected or the exact order in which individual employees will be separated. This information is intended to meet the requirements of any state, local or federal notice laws that could apply. The union, all affected employees, and, by this letter, local government officials and the Wisconsin Department of Workforce Development have all been separately notified of these plans as provided under federal and state notice laws in the event that such laws may apply. If the dates of any layoffs are extended beyond the identified 14 day periods, additional notice will be provided in accordance with law.

The company will ensure that employees will be paid all earned wages and agreed upon benefits at the time of their termination, and/or in accordance with any agreements with the Union or individual agreement or arrangements with non-represented employees.
