This is to inform you that UNISON, Inc. ("UNISON") has begun conducting layoffs at its offices, including at the following addresses.

These layoffs are due to unforeseen business circumstances – specifically, the sudden and unexpected loss of contracts from various funding sources for UNISON, including but not limited the Milwaukee County Department on Aging, and the impact the loss of that funding has had on the agency. We anticipate that the number of affected employees will total fifty-three (53) employees. The employee separations began on December 21, 2018 and we anticipate will continue through January 31, 2019. These layoffs are expected to be permanent. There are no bumping rights associated with the positions. Employees will receive any benefits and wages to which they are entitled.

This notice is provided to the extent it may be required under the federal WARN Act, 29 U.S.C. § 2101 et seq. which requires in some instances, and encourages in others, the provision of notice to affected employees of a pending layoff. This notice is being provided at this time due to the unforeseen business circumstances outlined above, which UNISON could not have anticipated would occur. We have also notified all affected employees. As a non-union facility, there are no union representatives to notify of this change.

Attached as Exhibit A is a list of the job titles of positions that have been or will be affected, and the number of affected employees in each job title, and the office in which the layoffs have occurred or will occur.
