This notice is being provided pursuant to the regulations contained in the WBCML Law and WARN Act, which require affected employers to provide notice to certain government units or officials of a pending mass layoff or permanent closure.

This is to advise you that New LifeCare Hospitals of Milwaukee LLC d/b/a LifeCare Hospitals of Wisconsin, located at 2400 Golf Road, Pewaukee, Wisconsin 53072 ("the Company"), will permanently close and the Company anticipates its employees' last day to be on or around June 23, 2019.
