Amendment #5 to Agreement

Wisconsin Career Advancement Initiative Model Demonstration Project

This Amendment Number 5 (Amendment #5) is to the Interagency Agreement (Agreement) with an effective date of October 1, 2021, between the University of Wisconsin System, Board of Regents (University) and the Department of Workforce Development (DWD), on behalf of the Division of Vocational Rehabilitation (DVR).

The above-referenced Agreement is hereby amended as follows:

- 1. The pricing details included in **Amendment #4, Renewal Pricing** are hereby superseded and replaced in its entirety by the pricing details included in the attached **Exhibit A Renewal Pricing: 10/01/2025 through 09/30/2026**.
- 2. Section 6 (State and Federal Rules and Regulations) is amended to include the following:

The Contractor shall at all times comply with and observe all federal and state laws, local laws, ordinances, and regulations which are in effect during the period of this Contract and which in any manner affect the work or its conduct including, but not limited to:

- i) OMB Guidelines to Agencies on Governmentwide Debarment and Suspension (Nonprocurement), 2 CFR Part 180, including the requirement to include a term or condition on all lower tier covered transactions (contracts and subcontracts described in 2 CFR Part 180, subpart B) that the award is subject to 2 CFR Part 180 and Treasury Department's implementing regulation at 31 CFR Part 19.
- ii) Byrd-Anti-Lobbying Amendment, 31 USC 1352.
- iii) Clean Air Act, 42 U.S.C. 7401 et seq., and the federal Water Pollution Control Act, 33 U.S.C. 1251-1387, as amended.
- iv) Whistleblower Protection, 41 U.S.C. 4712.
- v) Titles VI and VII of the Civil Rights Act of 1964.
- vi) Title IX of the Education Amendments of 1972.
- 3. Section 10 (Contract Revisions and Termination) is amended to include the following:

Agreements are made contingent on availability of funding. In the event of elimination of or any reduction in funding or the nonappropriation of funds by the Rehabilitation Services Administration for this grant, DWD may terminate this agreement without penalty or further obligation. DWD shall provide notice, in writing, to UW-Madison of termination due to loss and/or reduction of funding, and any such termination pursuant to this paragraph will be effective upon the date of the written notice, unless otherwise indicated. Notice by email shall be deemed sufficient.

Except as amended herein, all terms and conditions of the Agreement remain unchanged and in full force and effect.

This Amendment #5 is effective October 1, 2025 through September 30, 2026.
