Amendment No.4 to Contract ILF0004 – Competitive Employment Services Annual Outreach and Review Service

1. This amendment is made by the University of Wisconsin Whitewater (UW-W) and the Department of Workforce Development (DWD), on behalf of the Division of Vocational Rehabilitation (DVR), parties to the Annual Outreach and Review Service Contract fully executed on September 29, 2016.

2. The Contract is amended as follows:

Page 7, Section 6 Individual Meeting Components-Provision for Partial Delivery of Service: Upon missed meeting due to no show on part of 14c worker has been revised to read as follows:

If a 14c worker does not attend meeting during contractor's initial scheduled site visit, contractor may not invoice as a No Show.

In cases where contractor returns for another regularly scheduled site visit, contractor may invoice for 100% of the per person interview rate if interview is completed. However, if the 14c worker does not attend, contractor may not invoice as a no-show.

If the 14c worker requests an interview after the Contractor has completed all regularly scheduled site visits, the Contractor may invoice for 100% of the per person interview rate if the interview was completed successfully or the Contractor has completed and documented all outreach attempts to conduct the meeting without success. In these cases, Contractor must first offer to conduct the interview remotely e.g. teleconference, Skype, Facetime, etc. An in-person interview is permissible if deemed in the best interest of the 14c worker.

Page 7, Section 7 Reporting Plan-

The following data reporting elements to be implemented by Contractor at no extra charge:

Annual report to include information about how many individuals have left 14c employment and where they went (if known) based on the number of employees who were not interviewed during FY20, who were in FY19 and/or those reported by a 14c employer as inactive.

Annual report also to include how many 14c workers have moved from one 14c employer to another.

Page 18 Attachment A-Cost Sheet Proposers Cost Per Individual, Per Year (in USD) has been increased to **\$191.07**.

3. Except as set forth in this Amendment, the Contract is unaffected and shall continue in full force and effect in accordance with its terms until 06/30/2020. If there is conflict between this amendment and the Contract or any earlier amendment, the terms of this amendment will prevail.
